When a mark is filled in more than one class we offer a 10% discount on professional service fees for all subsequent classes.

\* Additional work such as corresponding with the Registrar of Trademarks following Official Action concerning objections, restrictions or limitations to the registration will be billed at \$180.00

Any additional work pertaining to additional Office Action or Opposition will be billed on the basis of our hourly rates which range from \$325.00 per hour upwards.
